Sub.: Online Re-examination on 09th and 10th March, 2021 the papers / courses of various Postgraduate Degree and Diploma Programmes, where the fresh/ Repeater/ ATKT Examinations were being conducted in March, 2021.

All the concerned are hereby informed that, the Board of examinations and Evaluation of the University at its last meeting held on 06.01.2021 has decided to conduct the Online Re-examination in the papers/ courses of the post-graduate degree and diploma programmes, where the students could not appear due to technical and other reasons and where the examinations were postponed owing certain reason. The Online Re-examination will be conducted only in respect of the following cases.

- 1. The examinations which were postponed by the University.
- 2. The Programmes/ Courses of Studies, where the Time-table of Examination was not defined on the Portal and consequently, the examination was postponed.
- 3. The translation of question-papers set in English was not available in other medium of instruction, such as Marathi, Hindi and Gujarati or the translated versions of question-papers were not available to the students/ candidates at the time of Online Examination.
- 4. The papers/ courses of studies/ programmes where the students were not considered on the Online Examination Portal either for full or partial examination for some reasons.
- 5. The students whose examination forms were not inwarded although they were duly admitted to the concerned year/ semester of the programme/ course of studies on the Digital University Portal.
- 6. The verification and uploading of the registered cell-phone number of the student was not carried out.
- 7. The students who could not appear for the concerned examination due to technical and other reasons.
- 8. The students who could not completed their examination, after logging in the Online Examination Portal, due to technical or other reasons.
- 9. Those students who could not appeared for the Examination on 23<sup>rd</sup> and 24<sup>th</sup> February, 2021.
