Madam,

The NEP-2020 has emphasized that "Teachers truly shape the future of our children and therefore, the future of our nation. The motivation and empowerment of teachers is required to ensure the best possible future for our children and our nation. Teachers will be recognized for novel approaches to teaching that improve learning outcome in their classrooms". To motivate teachers, the Ministry of Education, Govt of India has been organizing National ICT Award for School Teachers. The awards are given in recognition of effective and innovative integration of ICT in promoting students learning.

For the year 2018 and 2019, adequate advertisements were released and stakeholders in the States/ UTs/ Autonomous bodies were informed well in advance for submission of nominations. Till date, we have received 197 nominations from 33 States/ UTs/ Autonomous bodies under Ministry of Education - Gol and School under Ministry of Defence (Andhra Pradesh, Assam, Bihar, Chinattisgarh, Goa, Gujarat, Haryana, Himachal Pradesh, Jammu & Kashmir, Jharkhand, Kamataka, Kerala, Madhya Pradesh, Maharashtra, Manipur, Meghalaya, Mizoram, NCT Delhi, Odisha, Punjab, Rajasthan, Tamil Nadu, Telangana, Tripura, Uttar Pradesh, Uttarakhand, Puducheny, Andaman& Nicobar Islands, CISCE, CBSE, Sainik School Society, KVS and NVS). Details about the nominations received are attached herewith.

As per guidelines of the ICT component under Samagra Shiksha, the selection process for identifying the awardee teachers for ICT Award involves the following.

1 Teachers have to apply to the Directorate of Education of their States/UTs/Autonomous Agencies through their District Education Officer/ Regional Offices. For the first time teachers submitted their entries through ICT Award Portal by filling an online application form (http://ictaward.ncert.gov.in)

2 A Committee under the Chairmanship of Secretary (Education)/ Commissioner/ Chairman/ Director of the concerned State/ UTs/ Autonomous Agencies scrutinized all the entries and nominated the shortlisted candidates (double the number of their awards quota) and uploaded the same on the ICT Award portal.

3 These short listed candidates are now required to make presentations before the National Level Jury for the final selection. The composition of the committee is as follows:

Each awardee teachers will be awarded with a laptop, a silver medal and a commendation certificate. All winners will form a community of resource persons through networking.

Accordingly, a meeting of the Jury members has been scheduled through Online mode from 5th to 9th February, 2021 from 9.00 am to 5.30 pm on all five days.

Keeping in view your expertise in the area, the Director, NCERT has nominated you to participate in the Jury meeting and provide expertise in selection of suitable candidates for National ICT Award for the year 2018 & 2019.

Madam/Sir,

This is with the reference to the subject mentioned above. The blended mode of teaching was discussed in the 547th meeting of the Commission held on 29.05.2020. It was discussed that HEIs should be allowed to teach up to 40% of syllabus of each course (other than SWAYAM course) through online mode and the remaining 60% syllabus of the concerned courses could be taught in offline mode. Examination for both 40% online and 60% offline teaching can be conducted offline. This provision may be created over and above up to 40% of online education permissible for SWAYAM courses. Examinations for SWAYAM Courses are essentially conducted in online mode. To prepare a concept note on Blended mode of teaching the Chairman, UGC has constituted an Expert Committee comprising of the following members:

Sub: CWSN e-Content - Meeting held on 20/08/2020

A meeting was held on 20th August, 2020, regarding the development of digital learning content for CWSN, under the chairpersonship of Sh. Manoj Ahuja (Chairperson, CBSE).

- 1. Sh. Manoj Ahuja, Chairperson, CBSE- Chairperson.
- 2. Dr. Subodh Kumar, Member Secretary, Rehabilitation Council of India (RCI)

The key points discussed in the meeting are as follows:

- PM eVIDYA (a programme for multi-mode access to digital/online education) was launched on 17th May, 2020. The programme highlighted on development of special econtent for visually and hearing impaired students. The National Education Policy 2020 prepared also provided special emphasis to this goal. The Working Group will focus on the objective of development of teaching-learning e-content and its accessibility on the DIKSHA platform for all 21 disabilities mentioned in Act.
- As the e-content will be hosted on "Diksha", the platform, website and app should be made compliant with accessibility standards in a time bound manner.
- To meet the objective, three sub-committees may be constituted that would overlook specific tasks related to:
 - a. DEVELOPMENT OF GUIDELINES FOR DIGITAL CONTENT FOR CWSN. This is required to ensure that based on these guidelines content can be developed and accepted for upload on Diksha under Vidyadaan. This sub-committee will be headed by Prof. Anupama Ahuja, NCERT, who may add other members on the basis of requirement and their expertise. This sub-committee may present draft guidelines within a month of its formation. The members of the Sub Committee proposed are in Annexure -1. The Chair of sub-committee is authorised to invite more experts as per requirement.

- b. COLLATION OF EXISTING RESOURCES AND ITS UPLOAD ON DIKSHA PORTAL. This may be pertinent for identifying any gaps in the existing knowledge repository that could then be plugged on a targeted basis. Dr.Behera, CIET will lead this Sub Committee. Members will include representatives from NIOS and other National Organisations. The Sub Committee will also assess the e-content production capability of existing National Level Organisation(s).
- c. CREATING AN INVENTORY OF COLLEGES AND ORGANISATIONS that are already working in the field of content development for CWSN. For example: SNDT University, Mumbai; Ramkrishna Foundation College Mission, Coimbatore; Deaf & Dumb Association, Indore. This sub-committee will be headed by Dr. Subodh Kumar, RCI, who may add other members on the basis of requirement and their expertise. This Sub Committee may be finalised by 24-8-2020.

This Sub Committee will also prepare an inventory of dedicated NGOs, organisations, associations, resource persons who can contribute in this endeavour as well as help to produce e-content.

- 4. Other important aspects that were also discussed in the meeting are as follows:
 - a. At present, digital content for CWSN comprises of simple text-to-speech (TTS) conversion of books for accessibility. It is also important to make the audio recordings of study material actually comprehensible, and not just accessible.
 - Additional focus needs to be given for development of content for children with intellectual disabilities, and on the means of digital assessment for CWSN.
 - c. For supporting CWSN, NEP 2020 envisions certificate courses for pre-service and in-service teachers to become special educators. The 10-month certificate courses provided by Rehabilitation Council of India (RCI) can be made ODL and put on "Diksha" for early training and availability of certified teachers for CWSN.
 - d. Availability of content NCERT has signed an MoU with ISL for collaboration and development of courses along Universal Design Learning (UDL) principles. The sign language courses provided by NIOS are in the process of being uploaded on Diksha. Audio recordings of textbooks are being created for radio broadcast under PM eVidya. The Barkha series of books created by NCERT encompassing UDL principles are digitally available for students.
 - e. The Working Group may focus on the development of digital content for CWSN, which in turn will lead to an inclusive society as envisioned under NEP 2020. This may be achieved by focusing on catering to CWSN requirements individually, or by Universal Design Learning principle for all students.

f. While in the long run we will move towards UDL for all content, at present we may collate all available e-content for CWSN to make it accessible to all. NCERT may develop a training module on UDL for training teachers and content creators.
